

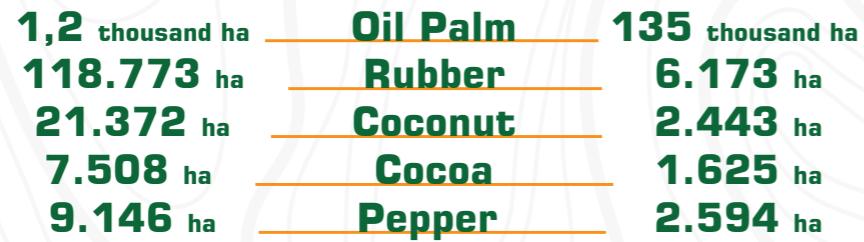

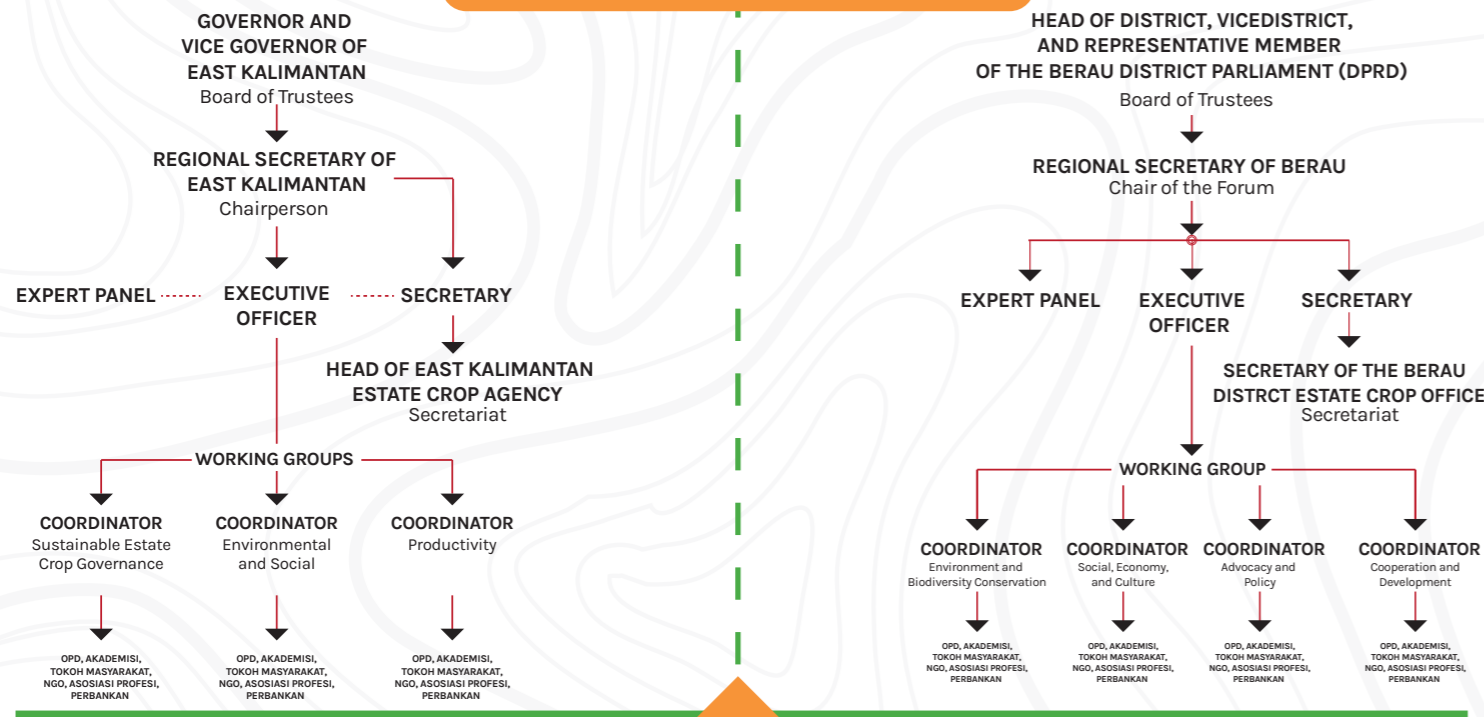
Berau District

Green Collaboration for Sustainable Estate Crop Communication Forum

Sustainable estate crop management is the key to strengthening the economy, increasing competitiveness, and protecting the quality of the environment in Indonesia. This is part of the Indonesian government's priority program. Sustainable estate crop management is also an important component in supporting ecosystem equilibrium and community welfare.

East Kalimantan is one of the provinces with the highest ecological and economic wealth in Indonesia. This province, with an area of 12.7 million hectares, earns a natural resource-based economic contribution from around 7.3 million hectares of tropical forests. The oil palm plantation sector, with an area of 1.37 million hectares, is a strategic commodity for regional economic and community development.

East Kalimantan, however, also faces challenges in the form of a legacy of three decades of forest degradation due to unsustainable natural forest management, oil palm plantations, and mining. In addition, forest fires are caused by the impact of human activities and the El Niño climate phenomenon.

FKPB's Kaleidoscope for Sustainable Estate Crop

The commitment of multi-stakeholder cooperation to encourage sustainable estate crop development in East Kalimantan was initiated.

December: FKPB of East Kalimantan Province was formed.

April: The Governor of East Kalimantan issued a decree on the appointment of the East Kalimantan Province FKPB management for the 2019-2022 period.

July: Berau District FKPB was formed.

October: The Berau District Government issued a decree on the appointment of the Berau District FKPB management for the 2019-2022 period.

December: Inauguration of the East Kalimantan Province FKPB management for the 2019-2022 period.

April: Berau District issued a regulation on the determination of indicative maps of areas with high conservation value in designated plantation areas covering 83 thousand hectares.

October: FKPB, together with YKAN, held the inaugural Bingka Kaltim webinar discussing a green development roadmap in Berau District through investment in sustainable commodities.

FKPB together with YKAN continued to organize a series of four Bingka Kaltim webinars.

November: The Governor of East Kalimantan enacted the regulation on the criteria for High Conservation Value Areas (ANKT) and the management of High Conservation Value Areas in designated plantation areas.

March: The last series of Bingka Kaltim webinar discussing the development of sugar palm as a food estate in East Kalimantan broadcasted online.

This condition will clearly have a serious impact on East Kalimantan's community welfare and ecosystem equilibrium. Green development and sustainable estate crop management can be a strategic solution for forest and natural resource sustainability through multi-stakeholder collaboration: government, academics, plantation industry players, and communities.

In developing collaborations for sustainable green development, the Estate Crop Agency of East Kalimantan Province works closely with Yayasan Konservasi Alam Nusantara (YKAN), Deutsche für Internationale Zusammenarbeit (GIZ), Climate Policy Initiative (CPI), Regional Council for Climate Change (DDPI) of East Kalimantan and other strategic partners. They developed collaborative activities within the framework of the Green Growth Compact initiative, which was officially launched in May 2016.

Estate Crop Communication Forum

Multi-stakeholder collaboration for green development aims to support estate crop sector activities in East Kalimantan that are in accordance with the principles of sustainable development and low emissions. Thus, this program can also support the acceleration of green economy transformation in East Kalimantan. Multi-stakeholder cooperation will also be able to achieve greater development outcomes for the community than if they worked individually.

This collaboration program also received great support with the ratification of Provincial Regulation Number 7 of 2018 concerning Sustainable Estate Crop Development. One of the mandates in this regulation is to establish a Sustainable Estate Crop Communication Forum (FKPB), which contains multi-stakeholder elements. Each of these forums is established by one institution at the provincial and city/district levels.

Prior to the formation of FKPB, there were already communication forums for estate crop sector stakeholders. However, there is still a need for a platform that can accommodate all their needs and become a communication channel to solve problems in the estate crop sector together. The DDPI plays a role in supporting to establish FKPB in East Kalimantan Province and Berau District. The two forums also get a stronger legal basis from local governments in supporting sustainable estate crop development.

FKPB is a strategic forum to engage stakeholders in sustainable estate crop programs. This organization involves representatives of local governments, individuals or corporations, professional associations, academics, and non-governmental organizations—working together to promote sustainable estate crop development. It is a communication forum for formulating, facilitating, and finding solutions to sustainable estate crop development and solving challenges in the estate crop sector.

The FKPB of East Kalimantan Province was officially formed in December 2018 with the support of Governor Regulation Number 52 of 2018, signed by Isran Noor, Governor of East Kalimantan. YKAN and DDPI provided full supports, both material and technical, to the East Kalimantan provincial government in accelerating the formation of the FKPB.

The area selected as a pilot for the establishment of the district-level FKPB is Berau District. This area has a wealth of natural resources in the form of 2.2 million hectares of forest, or about 75 percent of the total area. Berau District also has an area of 135 thousand hectares of oil palm plantations. In addition, Berau District also has estate crop areas for key commodities such as pepper, coconut, rubber, cocoa, and coffee. The Berau District FKPB was inaugurated in July 2019 through Head of District Regulation Number 52 of 2019, signed by Muharram.

Cooperation to Promote Sustainable Green Development

Through the analysis of its working groups, FKPB managed to identify a number of challenges to be resolved in the estate crop sector, including improvement of the institutional and organizational capacity of planters, financial access and development of estate crop technology, as well as optimization of licensed land uses and land conflict resolutions. In addition, FKPB continues the dissemination of sustainable estate crop regulations and acceleration of plantation certification.

The FKPB activities are also in line with the green development program that has been developed by the East Kalimantan Provincial Government. In 2018, the Governor of East Kalimantan released Provincial Regulation Number 7 of 2018 concerning sustainable estate crop development. This regulation aims to optimize the sustainable management of natural resources to increase regional income and community welfare. The establishment of FKPB received positive responses from stakeholders and estate crop communities in East Kalimantan. This institution bridges the information for estate crop business actors and participates in encouraging the issuance of regional regulations that support sustainable green development. They organize discussions and training on plantations and serve as a discussion platform for resolving issues and problems in the estate crop sector.

The outbreak of the Covid-19 pandemic in March 2020 made FKPB's offline activities stagnate. Despite the pandemic, the Forum, which is fully supported by the East Kalimantan Estate Crop Agency and YKAN, has pursued some initiatives, including holding a series of webinars entitled "Bingka Kaltim" (Sustainable East Kalimantan Commodity Talk). This webinar is one of FKPB's main programs to increase collaboration in the estate crop sector during the Covid-19 pandemic.

The Bingka Kaltim program, supported by YKAN, brought together experts and practitioners in discussing estate crop issues. The six topics discussed

at the Bingka Kaltim events were:

1. Green development roadmap in Berau District with sustainable commodities,
2. Supply chain and downstream of Berau cocoa to export markets,
3. Examining the Law on "Cipta Kerja" in the sustainable estate crop development sector,
4. Marketing strategy of East Kalimantan pepper in the global market,
5. Certification system for oil palm plantations in East Kalimantan
6. The prospect of developing sugar palm commodities to support food estate in East Kalimantan.

In its activities, FKPB also continues to encourage the improvement of ecosystem equilibrium and community welfare. The organization encourages the management of high conservation value areas and a jurisdictional approach to sustainable plantation certification. In line with these efforts, the East Kalimantan Provincial Government issued Governor Regulation Number 12 of 2020 concerning Criteria for High Conservation Value Area (HCVA) in Designated Plantation Areas and Governor Regulation Number 43 of 2021 concerning Management of High Conservation Value Area (HCVA) in Designated Plantation Areas.

Within three years, FKPB has made significant progress in promoting sustainable estate crop development in East Kalimantan. The model of this organization as a forum for multi-stakeholder communication can be a reference in the development of similar institutions in other regions in Indonesia. This productive collaborative initiative can be developed on a wider scale to achieve the common goal of building sustainable estate crop for the welfare of the community.
